This is a commercial product whose exact ratio of components may vary slightly. Minor quantities of other non hazardous ingredients are also possible.

## **SECTION 4 - FIRST AID MEASURES**

#### **General Information:**

**Inhalation:** First aid is not generally required. # **SECTION 6 - ACCIDENTAL RELEASE MEASURES**

Accidental release: In the event of a major spill, prevent spillage from entering drains or water courses. ## **Potential Health Effects**

Persons sensitised to sensitisers identified above should avoid contact with this product.

#### Inhalation:
