This is a commercial product whose exact ratio of components may vary slightly. Minor quantities of other nonhazardous ingredients are also possible.

SECTION 4 - FIRST AID MEASURES

General Information:

SECTION 5 - FIRE FIGHTING MEASURES

Otherwise, not normally necessary. Stop leak if safe to do so, and contain spill. Absorb onto sand, vermiculite or other suitable absorbent material.
